



### FROM YOUR MAYOR

Dear Residents,

I hope you all have had an enjoyable summer. I feel very fortunate to have had the opportunity to travel to China in June with family and friends. The trip was both fascinating and quite enlightening; China is a great country and the people there are wonderful. But in spite of some of the “noise” associated with the political Presidential process now upon us here at home, my recent trip leaves me most appreciative of the freedom to vote my conscience, as well the ability to speak freely and express my opinions. Despite its potential imperfections, we Watchung residents live in a very special town, state, and country. I feel quite lucky.

Your town is moving along on a number of fronts. We have completed a preliminary layout design of the new Library, and I encourage you to take a look online at what will be a two-story structure (only one story in the front and two from the Valley Road entrance). Our next step is to work with Arcari and Iovino Architects to review in October more detailed plans and cost figures.

A smaller scale design of the 9/11 memorial has been completed. We have dug several test holes, and everything is in line with moving forward. Contracts with several vendors are being finalized. Please join us for our ground-breaking ceremony at 9AM on Sunday, September 11<sup>th</sup> at the Village Green.

Over several years, Weldon has purchased all neighboring properties on its side along Bonnie Burn Road. The Planning Board has been working for over a year on the review and revisions to Weldon’s plans for expanded excavation of the quarry, while ensuring that a proper and effective buffer remains between the quarry and both residents and traffic along its perimeter, including Bonnie Burn. The Planning Board, and most recently the Mayor and Council, have approved changes to zoning under conditions which we believe will protect residents for generations to come.

With COAH (Council on Affordable Housing) now disbanded through a judicial decision, the adjudication of determining a municipality’s fair share of affordable housing now rests back with the judiciary branch of government. A recent NJ appellate court decision rejected a lower court ruling supporting the need for towns to adhere to what were significant low and moderate income housing obligations for the gap period 1999-2015. Inclusion of obligations for this gap period would have a substantial impact on Watchung. Fair Share Housing is challenging that ruling and it is expected that Watchung will need to substantiate what it believes are its remaining obligations.

A coalition of Mayors continues to strengthen its numbers and voice as it relates to its opposition to the Pilgrim Pipeline, who it is anticipated in the very near future will apply for permits in New Jersey to construct pipelines parallel to the PSE&G power lines on the east side of Watchung, as part of a 178 mile bi-directional pipeline between Albany, New York and Linden, New Jersey refineries. The proposed route crosses both many municipalities and sensitive environmental streams and aquifers. The Mayor and Council have approved sharing financial costs with what has grown to over fifteen towns associated with legal environmental support in opposition. Again, if asked by Pilgrim or an affiliate, you have every right to deny surveying of your property, which Pilgrim needs in order to apply for state permits.



**DID YOU KNOW A CRUDE OIL PIPELINE MIGHT BE COMING THROUGH WATCHUNG??**

Here are some facts about the project ...

Pilgrim Pipeline Holdings, LLC is proposing to build 2 new pipelines to transport Bakken crude oil and refined petroleum products between Albany, New York and Linden, NJ. This for-profit oil transport company would condemn private property to build their pipelines within feet of thousands of homes as well as schools, businesses and parks. It would permanently destroy wetlands and critical forest habitat for endangered species, and would cut through the Highlands region, endangering the drinking water for millions of New Jerseyans.

If approved, the Pilgrim Pipeline would run the length of Watchung, north/south under the high-tension wires that run parallel to Bonnie Burn. The pipeline would run adjacent to the homes on PHILLIP LANE, VAIL LANE, BIRCHWOOD LANE, OAKWOOD RD, and across VALLEY RD AND JOHNSTON DRIVE, near the power lines. It would also run close to BAYBERRY SCHOOL and MOUNT ST. MARY ACADEMY. If there was a leak or spill, the oil would contaminate wellheads and residential wells. The oil is highly volatile and an accident or explosion would be devastating to Watchung. Its presence could substantially lower property values.

Most of the NJ towns on the proposed route have passed resolutions or ordinances opposing the pipeline, as have both parties of the NJ State Legislature.

## TREE REMOVAL PERMITS

The Borough of Watchung loves its trees. Please, be considerate of the environment, your neighbor, your community and our trees.

The Borough of Watchung requires that ALL residents apply for a tree removal permit for the removal of trees, dead or alive. Any person desiring to cut or remove any deciduous or coniferous tree having a diameter of four inches or any Dogwood, Birch or American Hornbeam having a diameter of two inches must apply to the Borough Engineer for a permit to remove such tree(s).

JANUARY 31<sup>ST</sup> is the deadline for licensing your dog(s). All dogs six months and older must be licensed. You may obtain your license at Borough Hall, Monday – Friday from 8:00 AM to 4:00 PM or by mail addressed to the Board of Health, 15 Mountain Blvd., Watchung, NJ 07069.

**Include a self-addressed, stamped, return envelope.**

**You must also submit proof of rabies vaccination, which must be valid through November 1<sup>st</sup> of the license year (this is a New Jersey State Law).**

The fee for a spayed/neutered dog is \$12.00 and for non-spayed/neutered it is \$15.00. **A late fee of \$2.00 per dog will apply for all renewals received after January 31<sup>st</sup>.**

**If you no longer own a dog please call us at 756-0080.**

Anyone owning, keeping or harboring any unlicensed dog of licensing age will be subject to summons and possible fine.

## REMOVE YOUR PET'S WASTE

All of our communities have requirements regarding the deposit and removal of pet waste. These requirements are in place to protect the health of our populations, our properties, and to better assure pleasant environments. Unfortunately many people are either unaware of the requirements or do not follow them. Therefore, this is a friendly reminder that no person shall allow their dogs to soil, defile, defecate or commit any nuisance upon any public or private property whatsoever. Further, any person who curbs a dog shall immediately remove all feces deposited by such dog in a sanitary method and it shall be deposited in the owner's garbage. The deposit shall be properly wrapped, packaged or protected so as to prevent unsightly disposal or smell or interference with the health and welfare of the Borough. Please clean up after your dog!

## WELL WATER TESTING




If you have a well on your property then you should be testing your well, but you may not know what to test for or who can test it. Following is a short description of what you may need to know. There are many labs certified to test private wells by the State Department of Environmental Protection and the complete list can be accessed at: [http://www.nj.gov/dep/watersupply/pw\\_pwta.html](http://www.nj.gov/dep/watersupply/pw_pwta.html), however, below is a sample of labs, in no particular order, that are local or who have done work in our service area in the past. Please call and speak to them to get prices and to understand when they may be available to do the work you are requesting. Keep in mind, however, that if you are not satisfied with your response from these there are many other options available.

With regard to what should be tested for there are no requirements, unless you are selling your house. If you are selling, then the NJ Private Well Testing Act requires testing for **Nitrate, Iron, Manganese, pH, Volatile Organic Compounds (chemicals), lead, arsenic, and total coliform (bacteria)**. If total coliform is positive then a follow up test must be done for fecal coliform or E. coli. Even if you are not selling your house this list is a good starting point if you have not tested your well in some time. By testing for these items, you will have a good picture and baseline of your well's condition. Finally, if you suspect something is wrong with your well water or you have noticed a change (color, odor, etc.) I would suggest you speak to the laboratory or a well drilling company, as they will have a better understanding of the testing that might be needed.

“It’s very dangerous.” “People are flying.” “Does something terrible have to happen before you’ll do something about it?” Complaints of speeders on local roads are nothing new, nor are they unique to Watchung. I grew up on a residential street that was straight and flat, so when it came to people speeding while kids were playing, my father started his own form of a neighborhood watch long before signs that formally recognized the program started popping up. While his methods were highly effective, I simply cannot support them based on my current position. Although his methods may not be considered acceptable in a civilized society, there are other options.

When we receive these types of complaints the first step is to determine if there is a problem, and the second step is to determine the extent and the source. In some cases the complaints match our findings, but in most cases our data shows otherwise. That’s not to say that people are falsely reporting a problem, but the extent reported is often contradictory to our findings. If it’s your street where your kids play and where you walk your dog you don’t care about the extent, you just want it to stop. For everyone who wants it to stop, I suggest you start by checking your own speed. No matter how many times we conduct traffic surveys or run radar posts in these instances the results are always the same. Our residents, and those who complain about speeders, are the most frequent offenders.

Some will argue that a zero tolerance policy is the simple solution to this problem: you speed, you get a ticket. While everyone knows what zero tolerance means, they also have their own definition of a crisis. We want zero tolerance for others, but we expect special treatment when we’re involved. The offenders change, but the conversation with the driver is always the same. They “never speed” and they want a break “just this one time” because on this particular day their circumstances somehow justify their actions. “I never speed, but today”:

- I have an important meeting.
- I’m on my way to the airport.
- My son/daughter forgot his/her lunch, homework, sports equipment, instrument, etc.
- A repairman is waiting at my house.
- No one’s let the dog out since this morning.

You name it, we’ve heard it. When the other person does it there should be zero tolerance and they should get a ticket, but when you do it you want your “unique situation” taken into account.

I think we can all agree that waiting for something terrible to happen before any of this will change is a bad idea. A police presence can be highly effective, but we can’t be everywhere. When you do see an officer on a traffic post, do you flash your headlights to warn others? If we can all just start by slowing down and driving the same way you want people to drive on your street, most of this will take care of itself. Studies have shown that speeding during short trips on local roads does not actually save any time, yet our own residents on our own local roads are our most frequent offenders. As cars continue to become quieter and more comfortable it’s going to require that we all pay a little closer attention to our own speedometers.

## Deer are everywhere!

- There are over 15,000 deer-vehicle crashes in NJ each year.
- A deer crash can happen anytime — but half occur from October through December, and three quarters happen from dusk to dawn.
- Deer crashes can occur almost anywhere outside of dense urban areas.
- Many deer crashes occur on 2-lane roads with no median.
- Every year, deer crashes in New Jersey cause millions of dollars in vehicle damage, injuries, and even deaths.

## Reduce your risk!

- **Slow down** — if you see one deer, more may follow.
- **Don’t swerve** — If a crash is unavoidable, brake firmly and stay in your lane.
- **Keep headlights clean and aligned** — Use high beams when possible.
- **Always buckle up** — It could save your life.
