

FROM YOUR MAYOR

Greetings, Watchung Residents,

I hope everyone has found some time to enjoy the summer. I initiated a landscaping project on my own, but quickly realized the need for some help if I was going to get it completed before autumn! All this rain has limited a bit of our outdoor activity this summer, but at least there are no issues with reservoir water levels this year!

As this is my last official newsletter as your Mayor, I would like to once again provide the introduction to what is going on in our great Borough.

The Watchung Council in April, and again in July, voted to NOT support future funding in the investment of a library facility in Watchung. As I have previously stated, a physical library presence in Watchung is vital should Watchung want to maintain its excellent reputation as one of New Jersey's "Best Places to Live" (New Jersey Monthly, September, 2017). At this writing, the Council also has refused residents' repeated requests to have a referendum on the November ballot to let the residents decide if Watchung should have its own library.

And the residents wish to be heard! Over 700 residents have signed a petition asking that the Council invest in a new library in Watchung. Over 100 emails have been received by the Mayor and Council in support of a new library, and requesting that a referendum be put on the ballot in November.

While not everyone uses the library, the services provided are diverse across all age groups, and its presence is foundational as a means to support and enhance our community. I have been talking for years about the need to find ways to build a stronger "sense of community". Along with our schools and places of worship, I have always advocated that there is no better source of community presence than the Watchung Library. In 2016, over 49,000 items were borrowed; 198 children's programs (4,398 kids in attendance) and over 200 adult programs (1,716 adults in attendance) were hosted by the Watchung Library. What happens to displaced programs like these, as well its participants? Do you believe that Warren's library can meet the needs of our residents in addition to those of its own deserved residents? Can you imagine the increased opportunities we would have if Watchung had a library with more space and a facility that could better meet the present and future needs of residents, for its programs, education and tutoring, awareness training, and technology and services, etc.?

Libraries play an important role in our society, and for many it serves as an "economic lifeline" (Market Watch: Personal Finance Daily, 07/25/18) to individuals looking for employment. As Watchung already experiences, its library serves many constituents of varied needs and age groups.

Real estate agents and agencies have come forward to argue the perceived benefits of a library to prospective homeowners. Most agree that many young families will look elsewhere (Warren, maybe?) if a library, like a good school, does not exist to enrich their children's education.

Please take note: the Council voted on April 19th and again on July 19th not to invest in a library facility, thereby taking a course that will eventually force the closure of the Watchung Library doors. Establishing "shared library services" with Warren and taking possession of the Firemen's Exempt Hall and trying to use it as a "community center" will not satisfy what the town needs, both in terms of library services and as it relates to a community center. The thought that a fifty year-old Exempt Hall can be retrofitted to meet the needs of a community center, without its integration with a facility providing library services, substantively "misses the boat" as it relates to the value provided when, alternatively, a professionally-staffed library and community center are physically integrated. Those closest to understanding the present and future needs of a library and community center will tell you that those needs could never be met by shared services and the Exempt Hall.

It is anticipated that the State will be issuing its application early this fall for NJ towns to apply for matching library state funding, free, on a first-come, first-serve, basis. Your Mayor and Council have worked hard to be fiscally responsible; however, the Council's decision not to bond for new library reconstruction will eliminate the Borough's opportunity to then apply to the state for 1:1 funding. By voting 5-1 to not invest in a library facility in Watchung your Council has essentially eliminated Watchung residents'

opportunity to potentially secure, for free, a \$1M-\$1.5M investment in Watchung! This is fiscally irresponsible. This funding would have reduced effectively by half (equating to approximately an average of \$40/household per year) the financial commitment that would be expected from each household for a new library. While some may say that Watchung will “save” by not building a library, on the contrary, ultimately this will hurt assessed property values and Watchung’s stature and image; nothing will have been saved. All this, in addition to the incredible lifetime benefit and value a library could provide to all of its residents.

And Watchung will still have to pay the annual County Library Tax in excess of \$875,000, regardless of whether Watchung has a library facility or not; so it is clear that Watchung will be getting even less benefit in return for this annual county tax. Watchung has precious little time to change its course, thus the reason for outlining again the issue. Contact your Mayor and Council now, if you have not done so already, to let them know what you are thinking.

On another important topic, Watchung has been a defendant in the Fair Share Affordable Housing litigation, and the Mayor and Council have been working very diligently on the issue. The Council voted in June to move forward with plans to build affordable housing units off of Bonnie Burn Road, as part of a market-priced development. These actions will effectively help Watchung meet its third-round affordable housing obligations. This was an extremely tough decision to have been made by the Mayor and Council. With a 3-3 vote, I cast the deciding vote. While this whole issue is of great concern (as it relates to e.g., impact to schools and traffic), four of us believed that not doing something now would have, with most certainty in my opinion, resulted in a judicial decision to declare “builders’ remedy”, legally then approving the construction of potentially double the number of homes, including low and moderate income homes. While I understand the impact of this vote on our residents, the impact to Watchung if builders’ remedy is approved by the court would be catastrophic to the area. Watchung’s decision to move forward is consistent with every other town in the area, most of whom have already worked through a settlement with NJ courts. The key is to now get judicial approval and then depend upon the Planning Board and Mayor and Council to ensure that a high quality development is the result.

Summer is also a time for road work, and the town is hard at work doing milling and paving (and possible drainage) in numerous locations, including (weather-permitting): Ellisen, Parlin, Phillip, East Drive, Carrar, Anderson (Upper), Lakeview, Shady Brook, King Richard, Sequoia, Bayberry (upper), Price, Old Somerset (East), Old Somerset (Orchard-Sunbright), Robin Glen, Stanic Brae, Johnston Drive (lower).

We believe the problem (gas station spillage) at the entrance to Watchung at Spratford Park finally has been remediated. The Texier House was painted and now plantings will be added. There are new plantings along Somerset Street. Plans also are being made now to extend, later this summer, one of the existing lake walkways to the 9/11 memorial, where personalized purchased bricks will be placed. We have initiated planning around the future dredging of Watchung Lake, as well the reinforcement of its embankment.

Two of my long-standing requests are being fulfilled: first, all Council meetings are now being videoed so that our residents have greater access to what takes place at Council meetings. Plans also are being made to purchase an electronic sign for the front of Borough Hall. This sign was a top priority identified as a result of the “after action review” I conducted with Borough leadership after the weather events of earlier this year. Office of Emergency Management continues to ensure that plans and provisions are in place for future emergency events; more information is to come on this, including what role Watchung residents can and need to play.

It has been a pleasure serving you as Mayor for what will be almost six years (in addition to eight years as a councilman) at the end of this year. A lot has been accomplished, and yet there is a great deal more to do; all of which I will discuss in a closing letter to you in December.

DUAL STREAM PILOT PROGRAM

County Recycling Program will undergo some changes soon!

The Borough is a participant in the house to house recycling program with Somerset County. The County will be making some changes to the program very soon. Some highlights follow:

1. The county will be distributing two (2) separate 65 gallon totes (containers) to residential property owners. One (1) tote will have a lime green lid and the other will have a yellow lid. Residents will receive these totes (containers) from the County free of charge. But if you move from Somerset County, these totes are to be left at the residence for the new owner.
2. The 65 gallon lime green lid tote will be for newspapers, junk mail, magazines, catalogues, envelopes, corrugated cardboard, paperback books, most types of paper, etc. The 65 gallon tote with the yellow lid is for aluminum, all glass bottles, glass jars, plastic containers, etc.
3. Not all of the Borough will begin this modified County program at the same time. The western part of the borough along with the far north end (Ridge Road, High Tor, Phillip Lane, etc.) will commence soon.
4. The County stipulates that these totes are to be used for recycling only. Continue to place totes curbside the night before the regularly scheduled pick-up. The County asks that totes not be placed behind vehicles, mailboxes, utility poles, etc. so that the totes can be more easily picked up by the County crew. also, the County cannot take plastic bags, styrofoam, garbage cans, flower pots or kitty litter containers.
5. The County will be sending out information through the media shortly. Any questions should be directed to the County Recycling Division who can be reached at 732-469-3363. Thank you for your cooperation and participation.



LYME DISEASE

Lyme disease is transmitted through the bite of an infected tick. The ticks are often found on the body in the groin area, armpits, and scalp. Typical symptoms of Lyme disease are fever, headache, fatigue and sometimes a skin rash that looks like a bull's eye. The good news is that Lyme disease is preventable. It is preventable because ticks need to be attached to you for a fairly long time for them to transmit the disease.

To prevent Lyme disease:

- Remove tick habitats (high grass and weeds).
- Avoid walking in wooded, bushy areas with high grass or leaves and when walking in the woods, walk in the center of the trails.
- Use an insect repellent that contains at least 20% DEET when outdoors.

Perform "tick-checks" regularly (at least daily) to prevent ticks from attaching and follow the steps below to remove identified ticks.

Use a fine-tipped tweezers and grasp tick as close to the skin as possible.

Pull upward with a steady, even pressure.

After removing tick, thoroughly clean the bite.

If you feel that you have been exposed to Lyme disease, please contact your physician.



PET WASTE

The Health Department continues to receive complaints of pet waste not being picked up and being left on the ground. This is a violation of local ordinances. It also represents a public health hazard to humans and pets as it can transmit disease. For the health and enjoyment of all, please clean up after your pet and be sure to wash your hands!

RABIES CLINIC

The **Middle-Brook Regional Health Commission** will be offering multiple rabies clinics in the fall, one of which will be held in Watchung, tentatively scheduled as noted below. Please call to confirm the date and time in the fall. Rabies vaccination is the best defense for our pets. If your pet has been previously vaccinated the health department recommends that your dog or cat be vaccinated every other year. If your pet has not been vaccinated against rabies, now is the time. **The clinic is free to all.**

“GREEN TIPS” from the ENVIRONMENTAL COMMISSION

** RECYCLE! Read through the SOMERSET COUNTY RECYCLING brochure to see the rules for curbside recycling and a complete how-to guide, plus a list of dates for shredding, electronic waste recycling, and hazardous waste recycling. Take plastic bags to Shop Rite or Kings for recycling. Plastic bottle caps can be recycled at the library (they are thrown away by the county). Go to www.co.somerset.nj.us/recycle

**Try ORGANIC, NATURAL WEED CONTROL on your property. Chemical products like Roundup are damaging and toxic to wildlife and spread easily through the air or rainwater to your neighbors' yards. This easy-to-make recipe really works and is totally non-toxic: 1 gallon organic vinegar with 20% acidity (not normal vinegar, which has only 5% acidity) + 1 tbsp dishwashing liquid. Mix and spray or pour. Apply on a warm, sunny day when no rain is predicted for at least 2 days.

**COMPOST coffee grounds, tea bags, eggshells, vegetable and fruit scraps, and leaves and grass that haven't been treated with chemicals. This will give your garden a boost and reduce what goes into landfills.

**Bring your own REUSABLE SHOPPING BAGS and produce bags to the supermarket. Take cloth or other reusable bags to any store you visit so you won't need the plastic bags they offer.

**Consider driving a HYBRID or ELECTRIC CAR. They drive like any other car and the only difference you'll notice is how little you spend on gas!

**BUY GREEN PRODUCTS, such as: cleaners made of plant materials (like 7th GENERATION), no VOC paint, and products made of recycled materials, like notebooks, copy paper, countertops, tile, doormats, and napkins and other personal paper products (all MARCAL products are made from recycled paper, not trees!).

**Give up plastic water bottles. Use a WATER FILTER at home and carry a PERSONAL REUSABLE WATER BOTTLE with you.

**PLANT FOR POLLINATORS. Many pollinators are threatened or endangered. Butterfly bushes and milkweed are great for pollinators. Milkweed is the only place Monarch Butterflies lay their eggs and the only food source for their larvae.

**Use a NATURAL or ORGANIC DRY CLEANER, instead of one that uses harsh chemicals.

**RECYCLE CLEAN, WHITE STYROFOAM (non-food) year round, 24/7/365 in outdoor bins at FOAM PACK 72 Fadem Rd. in Springfield (just off of Rt. 22). Google them for more info or call 973-376-3700

**DEER REPELLENTS work well for plants and shrubs. Spray later in the day to avoid affecting active pollinators.

**TRIM TREES AND BUSHES LATER in spring or in the fall to avoid disrupting nesting birds and their offspring. Keep in mind nests are often well-hidden. Dead and downed trees and stumps provide homes for birds and other wildlife and provide food as they decay.

**DON'T LAUNCH HELIUM BALLOONS. The materials can be deadly to land and sea creatures that might mistake them for food.

**LIMIT FERTILIZERS. They can run off into waterways and cause undesirable water conditions, like algae bloom.

**USE TRAPS, NOT D-CON, to remove mice and rats from your home. Non-targeted animals can be impacted or killed by the poison of D-CON. For rodent protection, seal up cracks to the exterior of your house.

**Use PAPER STRAWS rather than plastic ones.

**RESPECT WILDLIFE. Wildlife helps the environment! Opossums can eat up to 5,000 ticks per season and do not carry Lyme disease. Spiders are beneficial and eat many of the insect pests that bother us. Save wildlife rather than kill them. Drive defensively in areas where there are deer and other animals and obey speed limits to avoid collisions.

** DISPOSE OF FISHING LINES PROPERLY, as carelessly discarded lines can entangle lake and sea creatures.

** Use a CAR WASH that RECYCLES WATER it uses.

WATCHUNG HISTORICAL COMMITTEE

The Historical Committee continues to explore a suitable home for the Watchung Mural and we hope to make a recommendation soon. In the meantime, we are proceeding with the complete renovation and restoration of the Mural. We are using the grant money from the Somerset County and Cultural and Heritage Commission to complete the first step which includes mounting the Mural on appropriate backing. The goal is to make sure the Mural can be moved again without a major process in case it is ever necessary. This will be completed by the end of the year and then we will continue to raise funds to complete the renovation.

The video, *Reflections of Watchung, A Historical Journey into its Roots and Vibrant Past* is complete. This set of three DVDs contains about six hours of material and will be presented to the public in early fall. I know all our residents will be pleased with the outcome of this project. Although many people have worked on this video over the years and have contributed to its content, we must single out and thank Historical Member Chris Vander Fliet who is largely responsible for putting it all together and getting it done!

Another exciting project has been to copy and preserve the Civil War Diary of Captain William Davis Purlin so that it can be viewed and read by the public. Captain Parlin was the father in law of Congressman Charles Eaton. The diary was gifted to us from his great-grandson, former Watchung resident Charles A. Eaton, III. Captain Parlin led the first battalion of black soldiers freed during the war. It is a fascinating glimpse into the thinking of the past. We also have on display Captain Parlin's cap, glasses, and the bullet that grazed his neck! Worth seeing, so please come visit. This is a treasure for the Texier House.

We will be participating in Somerset County's Weekend Journey to the past again this year. Mark your calendars for Saturday, October 13, 2018 from 10:00 AM to 5:00 PM and Sunday, October 14, 2018 from 12 noon to 4:00 PM. We will be highlighting our video and the Civil War Diary. Last year, about 99 people from all over the state and out of state came to visit and the feedback was very positive about our little local museum!

Since the last Newsletter, the Committee has welcomed Amber Murad, Mary Ann Weber and Ralph Diem as members. We still have one vacancy on the Committee, so if you have any interest in becoming a member of the Committee, please contact me. We are a busy Committee with a long “to do” list, but it is fascinating work and there is never a dull moment. Think about joining us.

The deer culling season is fast approaching. Although no final decision has been made by the Borough Council at this time, we need to be prepared and ready in the event a program is authorized. The Borough is trying to secure all possible sites with those residents that are willing to give permission to utilize their properties for this purpose. Shooting is limited to designated sites in the program with the utmost safety and will only be done from elevated tree stands. If you are willing to allow culling on your property, please complete the portion below and return it to the Borough of Watchung by October 22, 2018. The continuation of the deer management program is strongly recommended by the Borough Wildlife Management Advisory Committee. Pursuant to Section 2-44.3b of the Revised General Ordinances of the Borough of Watchung, you, as a property owner participating in the BOROUGH DEER MANAGEMENT PROGRAM, are hereby notified that this "Authorization Letter" could become a government record subject to public disclosure under the Open Public Records Act. Your cooperation is appreciated.

TREE REMOVAL PERMITS

The Borough of Watchung loves its trees. Please, be considerate of the environment, your neighbor, your community and our trees.

The Borough of Watchung requires that ALL residents apply for a tree removal permit for the removal of trees, dead or alive. Any person desiring to cut or remove any deciduous or coniferous tree having a diameter of four inches or any Dogwood, Birch or American Hornbeam having a diameter of two inches must apply to the Borough Engineer for a permit to remove such tree(s).

NO BRANCHES, TRASH OR REFUSE WILL BE PICKED UP. ANY BAGS FOUND WITH TRASH OR STONE IN THEM WILL BE LEFT ON THE CURB



As we all enjoy the weather during the summer and fall, let's not forget that Mother Nature is busy preparing. As February 2018 was ending many of us were hoping for an early spring, but storms Quinn, Riley, Skylar and Toby had other plans for the month of March.

A little planning and preparing now could go a long way during a prolonged weather event. Here are a few things to consider in advance:

- be prepared to shelter in place for 3 days
- have enough nonperishable food for all household members
- a manual can opener
- have 1 gallon of water per person, per day on hand
- fill prescriptions in advance
- a battery operated radio for information and updates
- batteries
- flashlights
- fuel up your car before the storm arrives
- keep some cash in case banks are closed and ATM's are not working
- sign up for Nixle alerts
- check Watchung Borough's official Facebook page for updates

I'm sure there are other things specific to your needs and your household that you can think of, and we strongly recommend that you take some time now to identify and secure those items.

Please take a few moments to check out the www.fema.gov and www.ready.gov websites for additional information related to storm preparation and recovery. Also, if you don't already have one, there are two-sided refrigerator magnets available at Borough Hall with many helpful phone numbers, tips and reminders to help you prepare for and recover from a prolonged weather event.

To ensure that you are receiving accurate and reliable information during any local emergency including traffic alerts, storms, bear sightings, etc. please sign up to receive Nixle alerts and visit Watchung Borough's official Facebook page. Nixle is the Borough's emergency notification system and you can sign up to receive alerts by texting the word Watchung to 888777 or go to www.nixle.com for further information.
