**FROM YOUR MAYOR**

Greetings Residents,

2019 has been filled with much change and activity in the Borough. Since January we needed to fill vacancies in the Office of Emergency Management, Municipal Judge, Plumbing Official, Construction Official, Fire Inspector, Police Department, Tax Collector and Business Administrator. In September, we will be welcoming to Watchung our new Administrator, James Damato. Mr. Damato will be here full time and brings many years of experience and knowledge. We look forward to working with him. I want to extend a large thank you to our resigning Business Administrator Tom Atkins who has diligently served our community for the past eight years. Tom's experience and assistance has been a true blessing to the residents and employees.

Our Governing Body has been very busy with the work on each committee. We have increased transparency by publishing the details of all proposed resolutions and ordinances in draft form for each meeting so residents have an ability to see the details behind all actions being considered by the Council before the actual meeting. Our Clerk Michelle DeRocco was very helpful moving this initiative forward. In the finance area, we approved a lean budget with additions for town beautification and road resurfacing and are working to obtain an AAA bond rating which provides advantages for our Borough.

Our Recreation Committee has done a wonderful job organizing and coordinating various programs and events for the entire community that have been fantastic at bringing our residents together for fun and relaxation. Feedback from the residents was that this year's community picnic was the best ever. A special thank you to Linda Monetti for all of her work in organizing the events. The 2019 summer camp program for our children looks to be busy and fun. We are eager for continued progress to provide activities and events to bring our residents together and celebrate our great Borough. I have been meeting with residents one on one to share ideas and welcome the input and experienced help from both the residents and employees.

I met several times with the Exempt Fireman and the Watchung Chemical Engine Company/ Volunteer fire fighters and proposed the town financially compensate the Exempts for termination of the current lease with the Exempts and construct the new Library, Arts and Community building on the property located at the Exempt Hall which would include an area permanently honoring the contributions of our volunteer firefighters and the sacrifices they have made to protect our community as dedicated volunteers. The proposal also included that the Exempts could utilize the new building at no cost and coordinate their activities with the other library, arts and community activities within the facility. In addition the proposal provided the Exempts with exclusive use of the old Arts Center building until such time that the property was either rented, sold or redeveloped for the remaining term of the current lease on the Exempt Hall property. Unfortunately the Exempts declined the proposal. We have researched and met with an Architect to develop preliminary plans for the construction of the new library, arts and community building on the acreage behind the Exempt Hall. Soil testing was performed to determine if the site is buildable and the results confirm that the site can be built on. An Ad Hoc committee was formed to gather and enlist information and expertise necessary for the ultimate planning, design, construction and operations of the new facility to benefit all of our residents. We now have the task of bringing all of the information and expertise together so we can also complete the best possible submission of our grant application to the State for 50% matching funds. The Governing Body will also need to evaluate and assess the future use and activity for the old Library and Art Center properties for the financial and community benefits for our residents.

**HEALTHY LIVING**

The Watchung Board of Health, a dedicated group of local residents who volunteer their time to provide oversight and input to the health department, is interested in initiating healthy living activities amongst Borough residents. For example, they are considering programs that encourage walking and active living. We welcome your ideas because the Board wants any program they consider initiating to be a success, with your active participation.

**COMMUNICABLE DISEASE CONTROL**

One of the major activities of the health department is to investigate and prevent the spread of infectious diseases. While the health department personnel are trained, experienced disease investigators, we cannot do this job alone. Vaccination is a critical step in helping our work. Immunization against communicable disease, particularly childhood immunization, is considered one of the ten greatest achievements of public health in the 20<sup>th</sup> Century. It is recognized as one of the means by which public health has extended the average life span by 25 years over the last century. However, because of vaccine hesitancy, resistance, and other factors, we are seeing a reemergence of vaccine preventable diseases as evidenced by the recent outbreaks of measles across the United States. We know that vaccines are safe, effective, and one of the best ways to prevent illness and the spread of disease. My career as a Watchung police officer began in 1993, and as many of you may remember, the winter of late 1993 and early 1994 was awful! It wasn't snow. It was one ice storm after the next. Nothing melted, rock salt was ineffective, and the ice just kept piling up on the roadways. There were ruts in each lane on RT 22 where a car's tires would travel that were separated by mounds of ice that seemed to be part of the pavement. Changing lanes over those mounds of ice was quite an adventure and vehicles, including police cars, were stuck everywhere. We would have chains put on the tires of our police cars, but they would always come undone and tear apart the rear fenders. Fast forward to today and our police fleet looks completely different.

After that awful winter we always seemed to manage our way through the snow, but flooding from Hurricane Irene in August 2011 followed by an unusual and unexpected snowstorm in October 2011 and then Super Storm Sandy in 2012 proved to be the tipping point. Based on our topography we needed to reevaluate our fleet. Since then whenever it became time to replace a police vehicle, we purchased all-wheel drive SUV's instead of cars. Our SUV's make it through just about any storm conditions that we've faced over the last few years, and the latest addition to our police fleet now includes a Ford F-150 pickup truck.

We opted for a pickup truck because it is extremely convenient when it comes to deploying bigger pieces of equipment like stacks of traffic cones, barricades, or our portable light tower, but more importantly, we now have a 4-wheel drive vehicle. The SUV's are quite capable during a typical snowstorm, but the truck now gives us the ability to make it to most places regardless of what Mother Nature throws our way. With this overhaul of our entire fleet, we are now far better prepared to respond to wherever we are needed.

The deer culling season is fast approaching. Although no final decision has been made by the Borough Council at this time, we need to be prepared and ready in the event a program is authorized. The Borough is trying to secure all possible sites with those residents that are willing to give permission to utilize their properties for this purpose. Shooting is limited to designated sites in the program with the utmost safety and will only be done from elevated tree stands. If you are willing to allow culling on your property, please complete the portion below and return it to the Borough of Watchung by October 22, 2019. The continuation of the deer management program is strongly recommended by the Borough Wildlife Management Advisory Committee. Pursuant to Section 2-44.3b of the Revised General Ordinances of the Borough of Watchung, you, as a property owner participating in the BOROUGH DEER MANAGEMENT PROGRAM, are hereby notified that this "Authorization Letter" could become a government record subject to public disclosure under the Open Public Records Act. # Disaster Preparedness – Preparing Makes Sense

Emergencies and disasters can strike quickly and without warning and can force you to evacuate your neighborhood or be confined to your home. What would you do if your basic services – water, gas, electricity or communications were cut off?

Learn how to protect yourself and cope with disaster by planning ahead. Even if you have physical limitations, you can still protect and prepare yourself.

The Three Steps to Preparedness:

- \* Get a Kit
- \* Make a Plan
- Be Informed
- 

Step 1: **“Get a Kit”** of Emergency Supplies

For your safety and comfort, have a disaster supplies kit packed and ready in one place before a disaster hits. Assemble enough supplies to last for a **minimum of three days**.

Keeping your kit up-to-date is also important. Review the contents at least every six months or as your needs change. Check expiration dates and shift your stored supplies into everyday use before they expire.

Disaster Supplies kit: (For more detailed information visit- [www.ready.gov](http://www.ready.gov))

- \* Water – one gallon per person, per day
- \* Food
- \* Flashlight with extra batteries
- \* Battery-operated radio
- \* First aid kit
- \* Medications (7 day supply)
- \* Sanitation and personal hygiene items
- \* Copies of personal documents (medication list, birth certificates, insurance policies)
- \* Cell phone with extra battery
- \* Cash and coins (ATMs may not be accessible)
- \* Manual can opener
- \* Pet supplies (including food and vaccination records)

Step 2: **“Make a Plan”** for yourself, your pets and your family

Meet with your family and friends. Explain your concerns to your family and others in your support network and work with them as a team to prepare. Arrange for someone to check on you at the time of a disaster. Be sure to include any caregivers to your meeting and planning efforts.

Family Communications Plan: Carry family contact information in your wallet. Choose an out-of-town contact person. After a disaster, it is often easier to make a long distance call than a local call from a disaster area.

**If you have Disabilities or other Special Needs:** Register with NJ Special Needs Registry. The NJ Special Needs Registry is designed to help emergency responders locate and safely evacuate people who could find it difficult to help themselves in the event of a major disaster. The NJ Special Needs Registry is free, voluntary, strictly confidential, protective of your privacy, a way to protect you in a major emergency.

The Department of Public Works will have a **Fall Leaf Cleanup** beginning November 4th thru November 29th. This is for **leaves only** to be recycled.

Leaf pickup is limited to high density areas located within the following streets: Brookdale, Stirling, and Hillcrest Roads north to Evergreen Lane; Mountain Boulevard from Washington Drive to Rock Avenue; Johnston Drive to the water tower including Upper Drive and Johnston Drive Extension. **Outside of these areas you must call for a pickup.**

All leaves must be in **BIODEGRADABLE PAPER BAGS** only (can be purchased at most Hardware Stores or Home Depot) and placed on the grass area close to the road. **We Do Not provide the bags.**

**NO BRANCHES, TRASH OR REFUSE WILL BE PICKED UP. ANY BAGS FOUND WITH TRASH OR STONE IN THEM WILL BE LEFT ON THE CURB**

**Reduce Use of Single Use-Plastics**

Live sustainably and reduce your carbon footprint by following these simple suggestions:

- \* Use a personal, reusable water bottle instead of the plastic ones. Approximately 50 billion plastic water bottles are used each year in the U.S. and only 23% are recycled.
- \* Use a reusable cup instead of a disposable one. Most disposable cups are not recyclable, because they are made of hard to recycle materials like plastic coated paper or foam. By using a reusable cup, you reduce solid waste going to landfills and also reduce water usage, and reduce greenhouse gas emissions.
- \* When you dine out, bring your own reusable container to take home left overs.
- \* When buying fruits and vegetables, use your own reusable bag.
- \* When shopping, at a food store, mall or anywhere, bring your own reusable bag.
- \* Skip the straw. Most straws are made from petroleum, which is a non-renewable resource and impacts the integrity of the environment. If you must use a straw, use a paper, metal, or other reusable one

Step 3: **“Be Informed”**

Before a disaster happens it is a good idea to have a conversation with those in your support network: your friends, family and neighbors. Let them know your needs in an emergency situation; ask how they could assist with your plan and whether they would be willing to help.

The Community Emergency Response Team (CERT) program educates volunteers about disaster preparedness for the hazards that may impact their area and trains them in basic disaster response skills, such as fire safety, light search and rescue, team organization, and disaster medical operations. CERT offers a consistent, nationwide approach to volunteer training and organization that professional responders can rely on during disaster situations, which allows them to focus on more complex tasks. Through CERT, the capabilities to prepare for, respond to and recover from disasters is built and enhanced.

The CERT Basic Course training includes:

- Disaster Preparedness:** Addresses hazards specific to the community. Materials cover actions that participants and their families take before, during and after a disaster as well as an overview of CERT and local laws governing volunteers.
- Fire Suppression:** Covers fire chemistry, hazardous materials, fire hazards and fire suppression strategies. However, the thrust of this session is the safe use of fire extinguishers, controlling utilities and extinguishing a small fire.
- Medical Operations Part I:** Participants practice diagnosing and treating airway obstruction, bleeding and shock by using simple triage and rapid treatment techniques.
- Medical Operations Part II:** Covers evaluating patients by doing a head to toe assessment, establishing a medical treatment area and performing basic first aid.
- Light Search and Rescue Operations:** Participants learn about search and rescue planning, size-up, search techniques, rescue techniques and rescuer safety.
- Psychology and Team Organization:** Covers signs and symptoms that might be experienced by the disaster victim and workers, and addresses CERT organization and management.
- Course Review and Disaster Simulation:** Participants review and practice the skills that they have learned during the previous six sessions in a disaster activity.

**A friendly reminder to Residents and Realtors selling a home**

Before any one- and two-family or attached single family structure is sold, leased, or otherwise made subject to a change of occupancy for residential purposes, the owner shall obtain a certificate of smoke alarm, carbon monoxide alarm, and portable fire extinguisher compliance CSACMAPFEC, evidencing compliance with N.J.A.C. 5:70-4.19, from the appropriate enforcing agency.

The application for a CSACMAPFEC and a checklist of requirements are available at Borough Hall, or on the Borough website [www.watchungnj.gov](http://www.watchungnj.gov) click on the **Departments** tab – click on the **Fire Prevention** tab – scroll to the bottom of the page.

**October is Fire Prevention Month**

In 1925 President Calvin Coolidge proclaimed the first National Fire Prevention Week. The week commemorates the Great Chicago fire, which began on October 8, 1871, and did most of its damage on October 9. Since then, it’s been observed every year during the week of October 9.

**The 2019 Fire Prevention Week Theme is “Not Every Hero Wears A Cape. Plan and Practice Your Escape”**

**Essentials for creating your Home Fire Escape Plan:**

- \* Draw the layout of your home
- \* Mark two exits from each room (usually a door and a window) and a path from the exit to the exterior
- \* Choose a meeting place outside the home where the family will meet upon exiting
- \* Mark the location of all smoke alarms in your home. There should be at least one on each level of your home and in the vicinity of the each sleeping area

**Practicing the Plan:**

- \* Ensure that the entire family knows how to call 911. Be sure to provide the street address and town name when calling from a mobile phone
- \* Take a head count to ensure that everyone is present at the meeting place, do not re-enter the home for anything
- \* Inform the First Responders if everyone is accounted for, or if anyone is missing and give their last known location
- \* Involve the younger members of the family with developing the plan
- \* Practice the plan with all family members at least twice per year

**New Smoke Alarm Regulations in effect:**

The New Jersey Division of Fire Safety proposed and adopted regulations that require the use of 10-year sealed battery type smoke alarms. This technology precludes an individual from removing the battery, thus maintaining a working alarm. Also, the 10-year sealed battery smoke alarms are designed to last 10 years and be replaced. Utilizing this new technology to ensure a working smoke alarm, will go a long way to reducing fire injuries and deaths.

**Free Smoke Alarm!!**

The Fire Prevention Bureau has partnered with Kidde, WABC Operation 7 Save-A-Life Program and the New Jersey Division of Fire Safety to distribute a limited number of 10-year sealed battery smoke alarms to residents in need.

- \* The smoke alarms may be picked up from the Fire Prevention office during normal business hours.
- \* The name, address and phone number of the resident receiving the smoke alarm is required.
- \* One smoke alarm per resident please.
