REPORTS OF STANDING COMMITTEES

- 1. Administration & Finance No update provided.
- 2. Police Council President Robinson reported that the Police Department and the PBA are holding a Toys for Tots fundraiser this weekend at Police Headquarters. She informed of the police department's purchase of 5 fast water vests to assist officers who may have to rescue stranded motorists or pedestrians from flood waters and they expect to purchase an additional 5 vests next year. She also noted that Police is in the process of completing the paperwork to receive full reimbursement for the body worn cameras. She also spoke on the truck accident that occurred today on Hillcrest Road. Council President Robinson noted that unauthorized trucks are still coming down Hillcrest Road but is hopeful that the County will finally take action. Councilmember Hayeck thanked all first responders for their assistance relating to the accident today on Hillcrest Road.
- 3. Public Works / Buildings and Grounds Councilmember Eisenberg Knegten stated the process of asbestos removal at the Ness farm is underway. She also mentioned that bollards were successfully installed at the library bridge and also at Mobus Field. Councilmember Eisenberg Knegten also advised the Borough received the second quote relating to the repairs at Mobus playground. Lastly, she stated the Borough has 800 tons of salt on hand for any winter weather.

Environmental – Council President Robinson reported on the legacy book and the Styrofoam recycling Borough programs. She also said a policy was drafted for governing the Styrofoam program and a fact sheet for residents is available on the Borough website. Council President

Board of Health – Councilmember Jubin reported that the Board of Health last met on November 17th and discussed the upcoming 2022 budget. He also mentioned new topics discussed were future grant opportunities and the Mayor's wellness campaign. Councilmember Jubin emphasized the importance of educating our youth on the use and different types of cannabis. He also discussed formally honoring the Middle-Brook Regional Health Commission for their dedicated years of service to Watchung for the past 50 years.

- 8. Police Chief Chief Hart provided an update on police activity for the month of November. He also commented on the truck accident occurring on Hillcrest Road. He said as a result of the accident four people were transferred to the Hospital but thankfully none with serious injuries. He commended the first responders for their assistance in tending to the victims and cleaning up the roadway. Chief Hart also reminded everyone to be conscious of not leaving keys in their vehicles and discussed the process of the speed sign program.

- 10. Rescue Squad Council President Robinson encouraged everyone to attend the Tree Lighting Ceremony this Saturday at 5:30 P.M.
- 11. Emergency Management Carolyn Solon stated all COVID-19 plans submitted for the Borough Recreation programs have been reviewed and approved. She also said the Office of Emergency Management will continue to closely monitor the Boroughs COVID activity report and work with the local Health Department.
- 12. Attorney Attorney Murphy reported on Resolution R8 and Ordinance 21/12 listed for approval on tonight's agenda. He explained that the financial agreement listed is required to be passed via Ordinance. He also pointed out a typographical error in the Ordinance needing correction. He advised the Ordinance currently reads 13 percent through years 1 through 10 but should read 13 percent through years 1 through 15. He asked the Council to please consider this amendment to the Ordinance when approving it tonight on first reading. Attorney Murphy also stated the next step in this process is for

- 14. Clerk Clerk Gil said she received notification regarding the Special School Board Election and advised all voting districts will be consolidated to the Fireman's Exempt Hall. She also stated the vote by mail deadline is December 7th and reminded residents the Borough ballot drop box location is still open. She mentioned this weekend the Middle-brook Regional Health Commission is offering a free rabies clinic at the Watchung Fire House from 9 to 10 A.M. and also encouraged all residents to renew their pet licenses through the online portal. Lastly, Clerk Gil stated emails were sent out regarding reappointment to all our chairs and secretaries of various boards and committees. She asked if anyone wishes to be reappointed to please submit their volunteer forms before the end of December.

Councilmember Hayeck questioned the process of receiving a vote by mail ballot. Clerk Gil confirmed if you signed up to receive vote by mail ballots you will receive one for every election.

Administrator Administrator Damato was happy to inform the Council and public of a \$5,300 dollar rebate received from our Joint Insurance Fund representing a refund of premium dollars previously paid. He also mentioned the culvert repair work began on Monday at Elsinore Drive and is proceeding very well.
