❖ Borough Newsletter: Home Town Press

Clerk Gil reviewed the details of the program if the borough chose to partner with Home Town Press. Mayor and Council expressed their thoughts and concerns of the program and instructed the Clerk to research other organizations that might do the same to outweigh the benefits before committing to anything.

Safety Crossing Light on Stirling Road

Mayor Balla noted that several residents have requested certain additional safety measures for crossing Stirling Road by Valley View School at Verona. He commented on the existing crossing light and mentioned the car accident that occurred. Mayor Balla said he reached out to the County Engineer who is in agreement of installing a large overhead light fixture for safety purposes. If the Borough installed this, Administrator Damato advised he would need to get estimates and our Engineer would have to come up with drawings and specs for the installation. Administrator Damato stated this would be brought back to Council for discussion once a proposal was done.

Tamara Benc, Lakeview Avenue, asked the Council to step back from any plans to relinquish the barn property. She feels reducing our town center does not make sense and asks the Council to be pro-active in maintaining our Borough property. Council member Martino asked Ms. Benc to forward a copy of her comment to the Mayor and Council.

Virginia Hartmann, Ellisen Road, said one of the main reasons residents wanted the Council to build a new library was due to the lack of space. Ms. Hartmann feels an outdoor building could be used to store crafts and for small unvaccinated children to work on crafts. She also feels the space on the side of the library should be kept free if someday as a future improvement an elevator is installed. Council member Martino asked for Ms. Hartmann to forward a copy of her comment to the Mayor and Council.

Christy Hartmann, Watchung, asked if the Council has ever considered providing the newsletter to residents digitally with a link posted on the Borough website. Mayor Balla stated there is a link provided online for the newsletter and also a mailer sent out to residents who may not use the internet. Council member Robinson said this idea was brought up with the previous Borough Clerk who stated there was a majority of residents who do not visit the Borough website and a significant number of residents who do not use the computer. Mayor Balla strongly advised all residents to sign up for email options to receive emailed information from the Borough.
