Mayor Jubin read the following proclamations onto the record and provided Members of the Department of Public Works with a special recognition of their labor.

Mayor Jubin announced that May 23rd is the 97th birthday of Watchung.

PUBLIC PORTION / AGENDA ITEMS ONLY

- 1) Vonnie Mott, spoke on behalf of the Garden Club and thanked the Department of Public Works for all of their continued support and assistance and commented that she loved everyone coming together to show support for Arbor Day at the schools.
- 2) Kristie Hartmann, asked for further clarification on some of the payments made by the Borough. She questioned the payment made to BJs regarding the food challenge and inquired on the Phillips Field lease agreement and the expenditure for a pet fountain.
 - Administrator Damato advised that during COVID the Borough took in donations to purchase food for individuals who were unable to and those funds were used to purchase food and were delivered to the food bank.
- 3) Lynda Goldschein, inquired on an architect being hired to draw up plans for the library. She also commented on the repairs of the electrical box at the library, and asked who was responsible for placing rocks inside the circle. Administrator Damato provided a response.
- 4) Kristie Hartmann, questioned the cost associated with the Best Lake gate repair, payment to Bright View Engineering for Shoprite, and payments made to Appraisal Systems, Inc. Ms. Hartmann questioned if placing the rocks in the circle had to go through Somerset County for approval and

lastly asked why the Borough is paying the new Engineering firm three to four times more than the last firm.

CFO Bill Hance and Administrator Damato explained the specifics of each payment made. Administrator Damato advised the rock project did not have to go through Somerset County and explained that the rocks were placed specifically in that island because it is the only one without sprinklers therefore vegetation can't grow there effectively.

Councilman Hayeck provided comments relating to the scope of work done this year with the Borough Engineering firm compared to the years prior is incredibly more.

- 5) Phyllis Juette, expressed her thanks to the Mayor and Council for their decision to renovate the existing Library building and also thanked the Department of Public Works for all their hard work.
- 6) Lynda Goldschein, questioned if Councilman Dahl, as the president of the Little League should be recusing himself from voting on resolutions involving the Little League.

Councilman Hayeck thanked Councilman Dahl for the time and dedication he has put into the Little League and stated he did not derive any personal gains from the work done.

He mentioned last year the Borough Engineer was out to his property to assess the damages, and he has been expressing his concerns regarding this issue since 2011. He asked for this issue of inadequate storm management to be addressed promptly to prevent future damage.
