Mayor Jubin read the following Community Service Award onto the record.

Mayor Jubin and Council Members took turns expressing their thanks and gratitude for Ms. Fechtner and for all of her contributions to the Community.

Ms. Fechtner spoke on how her family planted their roots in Watchung and the process of building Cardinal Drive. She expressed how thankful she feels belonging to such a wonderful community.

- 1. Administration & Finance Councilman Fischer had no further report from what was posted.
- 2. Police Councilman Marano stated all the Borough fields will now have signs that they are smoke free facilities. He advised the new block party form is now available on our Police Department's website and mentioned there is a potential new Police Department candidate for hire, currently undergoing background investigation stage. He also reported that the Borough did not qualify for the license plate reader grant, on upgrades to the body cameras and police vehicle technology, awaiting County approval for the street sign dedicated to Officer Melchionda, and on the current officer in training for the scholarship program. Lastly, he reported on the ongoing grandparent scam.

Mayor Jubin advised all to be aware of the scam and asked for the information to be posted on the Borough website and social media.

3. Public Works / Buildings and Grounds – Council President Ead mentioned updated details are listed in the written report and the Department of Public Works is keeping busy with improvements.

#### 4. Public Affairs:

Environmental – Councilwoman Abi-Habib referenced the Green Team & Environmental Minutes on the agenda, but mentioned the preferred tree list on the website is currently being updated to streamline the planting process. She advised the Styrofoam recycling bins are being emptied every day and thanked the DPW and Environmental Commission for all their help. Updates on the plantings were discussed from Operation Pride and discussions occurred relating to the tree swallows who have made a home in Watchung. The State of New Jersey Conservation Wildlife Foundation is looking for bat counters and lastly, Council Member Abi-Habib reminded everyone the farmers market starts Tuesday, June 6<sup>th</sup> and will be located in the Best Lake parking lot.

Mayor Jubin suggested building a swallow house and also provided comments on what a success the Community picnic event was.

Recreation – Clerk Edith Gil mentioned the written report was posted.

Historical – Councilman Fischer reported on the Memorial Day service event. Mayor Jubin urged all residents to visit the Texier House for all of the Borough's history it provides.

Board of Health – Councilman Marano had no report.

- 7. Engineer Borough Engineer Jason Cline reported on the I-bank application submitted and advised they are in the process of scheduling a meeting. He also mentioned Department of Transportation Road project survey was finished.
- 8. Police Chief Police Chief Hart reported on the numbers for the month of May. He mentioned there was a bear sighting recently in the Mayor's backyard and provided safety reminders to residents.
- 9. Fire Official Fire Official Czuba reported on last months inspections and provided details on the new training systems.
- 10. Rescue Squad Councilman Hayeck advised a written report was submitted but highlighted the top responder for the month of April.
- 11. Emergency Management OEM Coordinator Carolyn Solon had no report.
- 12. Attorney Attorney Sordillo had no report.

- 13. Finance CFO Bill Hance advised the sewer bills were mailed out recently and due on July 1<sup>st</sup>.
  - Mayor Jubin spoke on the Energy Receipt Tax webinar he attended. He advised the State of New Jersey has been keeping funds from municipalities and out of 536 municipalities, over 420 of them signed to petition the Governor and legislature to start returning funds owed back to municipalities.
- 14. Clerk Clerk Edith Gil provided a reminder that early voting begins tomorrow, June 2<sup>nd</sup> and runs through Sunday, June 4<sup>th</sup> with further details listed on our Borough website. On Saturday, June 3<sup>rd</sup>, the County Clerk will have extended hours in their Somerville Office from 9am-12pm for voters who wish to receive a vote by mail ballot.
  - She provided an update on the CivicPlus Agenda Management software. She stated they are now looking to go live in August or September at latest. The assigned Implementation Consultant and Project Manager left Civic Plus and the Borough was assigned someone else, so this pushed back some pre-scheduled meetings. She also mentioned they are in the next stages and now looping in our Boards Clerk and the Board of Health Secretary for user training.
- 15. Administrator Administrator Damato provided detailed information on the proposed gas main replacement on Somerset Street. This process may be inconvenient for Watchung residents and people who pass though Watchung for a few months. Nixle alerts social media alerts will go out regarding this project. The Borough is looking to get additional information from them on exact timeframes to make this a smooth process.

- 17. Planning Board Mayor Jubin advised at the last meeting discussions occurred relating to the outdoor dining Ordinance which was recently passed.
- 18. Municipal Alliance Councilman Marano advised the Committee is currently focused on organizing project graduation.
- 19. Library Advisory Committee Councilman Fischer said farewell to Hannah Kerwin and thanked her for her service in Watchung.
  - Mayor Jubin expressed his thanks to Hannah Kerwin for all her time and dedication to Watchung.
- 20. Traffic and Beautification Council President Ead advised the Committee met on May 1<sup>st</sup> and discussed many topics such as upcoming landscape improvements, spring flower plantings, planting through the village green and many other areas around the Borough. She mentioned the next meeting is scheduled for Monday, June 5<sup>th</sup>.

Mr. Damato provided responded in regards to how many and where the cameras were placed. He explained cameras have a certain distance and angle they can pick up on to adequately cover a certain area. He also mentioned they will be installing their own poles to expedite the process. The need exists right now to secure these areas as the cameras there right now are outdated.

Ms. Hartmann discussed with Administrator Damato how these cameras will be monitored. She also asked for further clarification on a \$13,000.00 cost associated with the Watchung Little League and asked if the Little League will reimburse the town from the donations raised.

Administrator Damato directed CFO Bill Hance to look further into this cost and provide a response to Ms. Hartmann before the end of the meeting.

Council President Ead thanked the Police Department and EMS team for their hard work and dedication to the town.
