SPECIAL PRESENTATION

Dr. Julie Glazer
 Superintendent of Watchung Borough School District

Dr. Julie Glazer was present and formally introduced herself before the Governing Body. While she had separately met the Mayor and some Council Members, she wanted to formally do so before all and noted she looked forward to working together for the betterment of Watchung. Dr. Glazer also congratulated Lieutenant Zaiton and noted he was one of the first persons he met from the Watchung Police Department when she first started and was very proud of his

Councilman Gibbs thanked Dr. Glazer for being present and recalled that he met her during trunk-or-treat. He recalled a time, in 2006/2007, when Watchung was amongst the top schools and looks forward to her time here given her experience and qualifications.

Mayor Jubin commented that while the Borough and the School District were separate legal entities, there was no reason why we could not work together and support each other where possible. He looked forwarded to the schools participating in getting the word out to parents about upcoming events and bridging the communications between each other.

SPECIAL RESOLUTION

Councilman Marano read a brief biography on Sherif Zaiton, who started with the Watchung Police Department in 2009 after having graduated from Somerset County Police Academy in 2008. Zaiton was assigned to the Detective Bureau in June of 2013 and in 2018 he became the DARE instructor where he had

She asked for an explanation on this item as it appeared as though it was a way to get around the legalities of purchases and that it seemed to always go to the same organizations.

Administrator Damato clarified the confusion and explained that the allowable threshold is set by the State of New Jersey each year for all municipalities. In Watchung there is an additional layer of oversight, which requires any bills over a certain percentage of that threshold to be approved by Council; that number is currently \$6,600. Mr. Damato explained that we are required to get 2 quotes and that was always done.

Mayor Jubin noted we would take this under consideration if other committees experienced similar issues; he also invited members of the Rescue Squad to appear before Council for an oral report.

2) Harold Huggins, Resident, appeared before Council as a follow-up to his prior appearance and communication between him and the Borough Engineer on the issues with flood water management that he is experiencing on this property. He implored the Council to take action to remediate this issue.

Administrator Damato advised that the borough was being guided by the recommendations of the Borough Engineer, who had already gone out to inspect the area and had already provided his
