R8: <u>Introduction of the 2024 Municipal Budget</u> *Hyperlink to Budget – Public Hearing on April 18, 2024*

Councilman Gibbs clarified that this was one of many budgets, he's talked previously about the \$100 bill and thanked our CFO Hance for putting that together. He encouraged residents to always look at all the other budget that go into their tax bill component: local district school, the high school, the county, etc. Councilman Gibbs further elaborated that while the borough has lowered the tax rate further than what was originally estimated, residents would still see an increase in their taxes, and that was because the value of homes has gone up. He once again encouraged all residents to look at all the other budgets of the school and the county.

Council President Ead also clarified that the borough had no control over the county and state taxes, in addition to the school budget.
