FROM YOUR MAYOR

Greetings Watchung Residents,

As your newly elected Mayor I would first like to thank all of the residents and Borough employees for their help and assistance in providing information, history and ideas as I serve you as your new Mayor. Having lived in Watchung for the past 20 years I have seen a lot but there is also much to learn. My wife Karen and our three children Jonah, Noah and Hannah continue to provide their unwavering support and encouragement. I come to the office of Mayor with an open mind and welcome the input and experienced help from both the residents and employees.

We have set out an ambitious agenda for the coming year. We are working diligently to plan the new library with community meeting space for community events and activities. The library will house crafting areas with flexible space for additional programs like robotics and makerspace activities. We plan for the library to have space for performances and exhibitions to fully develop and integrate the arts activities and programs within the Borough to include additional programs with community and school interaction. Several suggestions are concerts on the Green, Craft and Arts festivals on the Green and photography and music programs involving our youth and residents. I will be appointing an ad hoc committee to plan for the building and the specific needs and requirements for the new facility to benefit all our residents.

I have met several times with the Exempt Fireman and the Watchung Chemical Engine Company/ Volunteer fire fighters and proposed to purchase the building from the Exempts and construct the new town building on the property located at the Exempt Hall which would include an area permanently honoring the contributions of our volunteer firefighters and the sacrifices they have made to protect our community as dedicated volunteers. As volunteer fire fighters they have been an example of public service and their volunteer service has been very cost efficient for the Borough. I look forward to the Exempts joining with the community to work together for the best viable plan for both the Exempts and the entire Borough of Watchung to cost effectively utilize the resources we have for the betterment of everyone in Watchung.

I had the opportunity to spend time with another volunteer service group, our Rescue Squad which has faithfully answered the call to serve the residents of Watchung. Both the volunteer fire department and the rescue squad are tremendous organizations for our residents young and old to give back and help within our community. I would strongly encourage all of our youth and older residents to visit both the firehouse and rescue squad for a tour to see the many opportunities available to volunteer and help.

Within the operations of the town there have been several retirements and several more likely over the next few years of the key employees within the Borough. I along with our Council are working to make sure we provide exceptional service for our residents. We are implementing plans to provide better transparency of information. We seek to provide all proposed resolutions and ordinances in draft form for each meeting so residents have an ability to see the details behind all actions being considered by the Council before the actual meeting. The Council meetings are now live streamed and recorded to enable our residents to view the meeting from offsite locations.

So far this winter has been mild and our Department of Public Works has answered the call with salt spreading and plowing when needed. We will be planning the dredging of Watchung Lake and reinforcement of the embankment and walkway in 2019.

I have also met with our Watchung Schools Superintendent and School Board President to look for opportunities to share services and resources to avail both the Borough and the school's savings to better manage finances.

I have been meeting with residents on a regular basis who have ideas and interests to better our community usually at 7:00am at the Mayor's office in Town Hall. Please reach out with your ideas and interests to serve and volunteer within our community. If we all work together for the common good, the lift is easy.

I thank you for the privilege and opportunity to serve as your Mayor and look forward to all the activities and projects for the spring and summer.



LANDLORD IDENTITY REGISTRATION

Based on what I've seen and heard so far, opinions seem to be closely split over the legalization of "recreational" marijuana for personal use. If at some point it is legalized in New Jersey, before that happens, there needs to be answers to how law enforcement will deal with driving under the influence of marijuana.

Last year in a survey of 11,000 marijuana users from Colorado where marijuana is legal, 69% of those surveyed said that they had driven while high within the last year. If that doesn't scare you, 10% of them actually said that it made them better drivers! Unlike testing drivers under the influence of alcohol, at present there is not a comparable test that can quickly and sufficiently test for marijuana impairment levels that has also been accepted as reliable by New Jersey's courts. Bodily fluids can be tested for the presence of tetrahydro-cannabinol or THC (the psychoactive ingredient in marijuana), but those tests take time. Even if there was a fast and reliable test for the presence of THC, we know that it can remain in the system for days or even weeks after marijuana use depending on how frequently it is smoked. In other words, just because there is THC in your system, that does not necessarily mean that you are under the influence of and impaired by THC.

Ideally, to prove beyond a reasonable doubt that a driver was under the influence of marijuana, we would need two things. First, we would need a positive bodily fluid test result from the state laboratory. Second, we would need the testimony of an officer specifically trained as a drug recognition expert (DRE) to say that in addition to the presence of marijuana in the driver's system, the driver was impaired due to marijuana use at the time of the arrest. Although necessary, the lab results will be a formality. Once a positive test result can be shown, why would the defense question or argue the presence of a legal substance? They'll admit to it, and then they'll attack the testimony, training, and credibility of the DRE. Defendants will argue that they smoke marijuana regularly to explain the presence of it in their system, while also denying that they were under the influence of marijuana at the time of the arrest. That may sound simple enough to overcome, but there's a shortage of DRE's in NJ and that training is costly and time consuming.

There are a number of other states that have already legalized the possession and use of recreational marijuana, and from their experience we have learned of some of the unintended consequences. In Colorado car crashes involving marijuana use are up. Marijuana related calls to poison control centers are up. Marijuana related hospital visits are up. The number of suicide victims found to have marijuana in their system has doubled. While those increases cannot be directly tied to the legalization of marijuana in Colorado, you also can't ignore those increases since the legalization of marijuana.

Some will argue that by regulating recreational marijuana use through legalization and taxation, it will lead to a windfall of revenue that was previously untapped. I would argue that even if those revenues trickle down to the local level, much if not all of it will go toward funding some of the unintended consequences of legalization. I'm against the legalization of recreational marijuana for several reasons, but I realize that decision is not up to me. Even if you support the legalization of marijuana, I hope you can agree that at the very least it would be a mistake to legalize it before the police and the courts are prepared to handle the arrest and prosecution of people who drive under the influence of marijuana on our roadways.

Clean Water NJ

In The Home

- Shop for nonhazardous, biodegradable and phosphorous-free household cleaning products.
- If you use water-based paints, rinse paint brushes in the sink. If you use oil-based paints, you can filter and reuse the thinner used to clean brushes. Dispose of thinner through a local household hazardous waste program. Visit www.state.nj.us/dep/dshw/rrtp/hhwcps.htm for a list of local household hazardous waste facilities.
- Sweep up dirt and debris and discard on your lawn or in the trash. Hosing off pavement washes pollutants into storm drains, which may lead to local creeks, bays and the ocean.
- Rather than wash your car in your driveway, on the street or in your yard, take it to a local car wash. This not only conserves water but also eliminates the running off of harmful
- Keep trash cans closed to prevent trash from scattering.
- If you use hazardous substances such as paints, solvents and cleaners, use them sparingly, according to the directions. Store properly to avoid spills
- If you are working on a home improvement project, dispose of drywall and hardened concrete and mortar in the trash or visit www.nj.gov/dep/dshw/lrm/classb.htm for a list of recycling centers. Do not rinse concrete or mortar from a bucket or wheelbarrow into the street; dilute the mixture with water and rinse it into an area with vegetation or gravel.
- Participate in local recycling programs. To find out more about recycling in your area, visit www.state.nj.us/dep/dshw/recycling/index.htm.
- Dispose of unwanted chemicals at a household hazardous waste collection center in your area. Never pour hazardous materials into the street, sewer or the storm drain. For more information, visit www.state.nj.us/dep/dshw/rrtp/hhwcps.htm.
- Eliminate or, at least, reduce the use of soaps and shampoos when using outdoor showers that drain to the street.

Litter & Recycling Tips

- Reduce, reuse and recycle materials whenever possible to create less waste, which could end up on our streets and contribute to stormwater pollution.
- Pick up trash and litter on your property and put it in the trash. Always use a public trash can for trash in public areas. Recycle any reusable materials, especially cans, bottles and paper. NEVER throw litter and debris directly into storm drains. Such debris can wash into waterways and onto beaches, and clogged
- drains can cause street flooding and traffic congestion. Always put your cigarette butts in ashtrays or solid garbage cans, not on the streets. Remember, our parks, playgrounds and beaches are not ashtrays. When an ashtray or garbage can are not available, store extinguished butts in your cigarette pack until you find
- a proper receptacle. Empty automobile ashtrays into the trash, not out your car window or directly on the ground. Proper disposal will help keep our
- Make sure to properly dispose of leftover household chemicals, paints and automotive fluids. These leftover chemicals should never be thrown away. Trees are one of Watchung's most valuable assets.

WHY TREES MAKE US FEEL SO GOOD

Trees are known to improve air quality by capturing six common air pollutants and toxic gases, including ground level ozone, particulate matter, carbon monoxide, nitrogen oxides, sulfur dioxide, and lead.

A young single tree can absorb 10 pounds of air pollutants per year and a mature tree removes up to 84 pounds of air pollutants per year.

Trees remove pollution from the air and soil, which provides benefits for air quality and human health, according to the U.S. Forest Service.

The net cooling effect of a young healthy tree is equivalent to 10 room sized air conditioners operating twenty hours a day.

Trees reduce erosion. Over 40% of water that falls in the area of a tree canopy will never reach the ground. A young maple can transpire 400 gallons of water which stabilizes the surrounding soil and reduces erosion.

Trees also provide shelter, housing, and food for a variety of birds, insects, amphibians, reptiles and mammals. Trees support plant life. Many varieties of plants that we enjoy have a symbiotic relationship with trees.

Trees require maintenance. Please cut the vines that are growing on them.

The Borough of Watchung requires a permit prior to removing a tree. The permit application is available at Borough Hall or online at Watchungnj.gov. Click on "Engineering Dept." If you have any questions, call Borough Hall at 908-756-0091.

SEPTIC CARE

Spring-cleaning does not just apply to your closets. When you think of spring-cleaning, you should also think about cleaning your septic tank. As a general rule of thumb, you should pump your septic tank every three years, but every household is different and depending upon your use and the age of your system, you may need to pump your tank more or less frequently. The bottom line is you need to pump and maintain your septic system to avoid problems and very costly repairs. See this septic guide for more detailed information about your septic system and its care.

STAGNANT WATER & INSECT CONTROL

It is springtime (finally) and along with the season comes rain and winter runoff. These conditions are ideal for creating pools of stagnant water. In addition, vacant or unsold homes may result in an increase in swimming pools that are no longer being maintained. All of this may result in breeding conditions for mosquito larvae. Mosquitoes are linked with diseases such as West Nile Virus (WNV) and Eastern Equine Encephalitis (EEE). If you live near a home that has a swimming pool that is not maintained please notify the Health Department at (908) 753-8000 ext. 239 and (732) 968-5151. For low-lying areas in your neighborhood that collect water, contact the Somerset County Mosquito Commission at 1-908-541-5021.

Below are other steps you can take to prevent mosquito breeding on your property:

- Make sure there are no items in your back yard (like garbage can lids, buckets, baby pools, recycling, plant holders, etc.) which can accumulate water.
- 2. Remove all tires without rims or any other garbage that can store water (like jars, cans etc.)
- 3. Remove accumulating leaves from drainage swales or drainage areas on your property.
- 4. Change water in birdbaths, fountains, and troughs weekly.
- 5. Aerate ornamental pools, or stock them with fish.
- 6. Clean gutters so water does not pool.
- 7. Make sure stored boats are not accumulating water. Store small boats upside down.

By using these simple control measures you can help reduce the population of mosquitoes around your home, reduce the chance of disease, and will be more able to enjoy the spring and summer months!

EMERGENCY PREPAREDNESS

The health department and other emergency response agencies are ready to assist during times of need, but our capacities and resources are limited. Therefore, it is critical that we all prepare for emergencies by making a plan and an emergency kit. Federal guidelines and recommendations from the experts suggest a kit of essential supplies for a minimum of three (3) days. This kit should include such vital items as water, non-perishable food items, medications, important documents, and many more items. For a complete list of items and instructions on preparing a kit, see www.ready.gov or http://www.redcross.org/get-help/how-to-prepare -for-emergencies. These sites also have valuable information on developing a personal preparedness plan, such as how to reach loved ones during an incident, identifying where you will meet and how you will communicate when traditional methods are not available. Legend of Watchung Mural

The Sears Mural – (painted by Garfield Hunter Jones around 1962 when the Sears store opened on Route 22 East), is in its final phase of restoration. The Legend of Watchung portrays the Dutch Captain Michelson, Chief One Feather and Princess Wetumpka the main characters of the Legend. The mural is a window into Watchung's history, and once restored it will preserve the legend and its history for generations to come.
